FATERNAL SUPPORT TO THE GENERAL STRIKE CALL OF CENTRAL TRADE UNIONS

The Central Trade Unions have given a call for a day's strike on 28th February, 2012 against price rise, disinvestment of Public Sector Equity, Contract Employment, Outsourcing and for demanding Rs.10,000/- minimum wages, Job Security, compulsory registration of unions within 45 days, enforcement of labour laws etc.

The Executive Committee of AIBOC, at its 66th meeting held on 17th & 18th January, 2012 at Kolkata, after due deliberations, has decided not to participate in the strike but to extend fraternal support to the Strike. It was also decided to communicate to the IBA/Govt., our displeasure in not resolving issues pending with them for a long time. It decided demand discussion Khandelwal Committee was further to on recommendations. Decision was also taken to observe a day's protest strike during the 3rd or 4th week of March, 2012, if the issues remain unresolved. The leadership of AIBOC will decide the date of the strike.

Comrades, many constituents of U.F.B.U. are participating in the General Strike on 28th February, 2012. We convey our moral support to the call of Central Trade Unions and extend fraternal support to the striking comrades of Banking Industry. We request you to follow the guidelines issued by AIBOC/Federation with regard to extending moral/fraternal support. Our members may join lunch time demonstrations and rallies, if any, organised by Central Trade Unions/UFBU constituents. For the sake of clarity, we wish to advise that our officers should neither perform clerical jobs nor should handle cash in any case.
