Com Shanti Da in his address, expressed his satisfaction over the initiative, involvement and commitment of all the Units' conveners present there. He stressed upon the need for the Units of Serving Officers' Organizations to extend all possible support including financial assistance to the Pensioners' & Retirees' Organization at the initial stage so that they can start off smoothly. The undersigned in his response, assured the house that this matter shall be discussed in the ensuing E.C.Meeting of our Federation, scheduled to be held at Goa on 16th & 17th June, 2012.

The arrangements made by Com. Sanjay Das, Pradeep Chaterjee and other office bearers of our Eastern India Branches Unit were appreciated by all.

The 1st Adhoc Committee Meeting of AIBPRC held on 15th May, 2012

The 1st Adhoc Committee Meeting of AIBPRC was held on 15.5.2012 at Academy of Fine Arts, Kolkata. Com. Sanjay Das welcomed all the participants on behalf of AIBOC West Bengal State Unit. Com. S.R. Sengupta & Com. Shantha Raju, Jt. Conveners of AIBPRC conducted the meeting. Com. P.K.Sarkar, President-AIBOC, presided over the meeting. He complimented the efforts of the stalwarts and leaders of yesteryears in formation of AIBPRC and informed the house about the decision of AIBOC Central Committee to provide a sum of Rs. 10 lacs to the AIBPRC. He further assured that all possible co-operation and support shall be extended to AIBPRC by AIBOC at every level.

Com. R.N.Banerjee, the founder member of State Bank of India Retirees' Federation in his address narrated the history of formation of their organization and complimented AIBPRC leadership. He enumerated several issues of retirees such as Uniform D.A.Formula, Family Pension, Updation of Pension and Medical Assistance to the retirees. He appealed the serving employees' organizations to include all these issues in their charter of demands for the 10th Wage Revision which is falling due on 01.11.2012.

Com. Shantha Raju in his address said that presence of AIBPRC is seen only in the capital cities & metropolis. He urged upon the house to make all efforts to penetrate little deeper and mobilize membership from other cities and towns. He informed the house that AIBPRC will submit a special charter for the Retirees to AIBOC leadership with an appeal to incorporate the same in their charter of demand for the 10th Wage revision.

Com. S.R. Sengupta, Jt. Convener of AIBPRC submitted his report to the 1st Adhoc Committee. There was some debate as well as extensive discussions on various points of the report. The report was appreciated by the house and was adopted with few modifications.

It was decided that another meeting of the conveners will take place at Bangalore to take a stock of the situation and there after a date will be finalized for the Convention of AIBPRC.

Comrades ,now it is the responsibility of each one of the Office Bearers/ Executive Committee Members of all Units as well as of the Federation to extend all possible support and co-operation in furtherance of the cause of AIBPRC , so as to ensure that it emerges as a strong & vibrant force championing the cause of Pensioners & Retirees of Banking Industry.
