HISTORIC 117th EXECUTIVE COMMITTEE MEETING OF OUR FEDERATION **LEGENDARY LEADER COM. M.Y. SHINTRE LAYS DOWN THE OFFICE OF PRESIDENT** **COM SUNIL KUMAR CO-OPTED AS PRESIDENT OF THE FEDERATION**

Our Federation held its 117th EC Meeting at Bhopal on 27th October 2012, coinciding with superannuation of our beloved President, Com. M.Y.Shintre, which was presided over by him. The undersigned presented the General Secretary Report dwelling upon various international and national issues covering political, economical, social & banking scenario, trade Union movement. Various issues discussed were UFBU strike/2nd option of pension to left outs, attack on trade union, formation of AIBPARC & FOBOIPARA at Chennai on 24th September 2012, Central Welfare Committee meeting, recent promotion process and our demand for increase in rates of subsidized accommodation.

General Secretary cautioned about the moves by the Government of placing the Banking Law Amendments Bill in the Parliament and a communication from ministry of finance, department of Financial Services, initiating steps to group the Banks with common CBS application platform; thus forming seven small groups with 3 or 4 Banks in each group and directing one bigger Bank, appointed as co-coordinator bank in each group, to have continuous and close interaction with group Banks & DFS on a quarterly basis with focused attention on areas of HR, BPR, E-governance, internal audit, fraud detection & protection, recovery and ALM, is nothing but the first step towards merger of Banks. He requested all units to remain vigilant and suggest ways & means to fight with the anticipated threat.

After the routine agenda was over, the General Secretary informed the house that this E.C. Meeting is the last meeting of Com. M.Y. Shintre as President of our Federation, as he shall be laying down the office of President of this Federation on 31st October 2012, on his superannuation.

The presidium placed before the committee the task of co-opting the next President of the federation for the remaining term of the committee w.e.f. 01.11.2012. House unanimously decided the cooption of Com. Sunil Kumar, Senior most Vice President for the post of President. We convey our Best wishes to Com. Sunil Kumar on his cooption as President and hope that under his leadership our Federation shall achieve new heights.

Upon filling up of the President's position, two positions of the Vice-President and three positions of Joint General Secretaries had to be filled up through co-option.
