**Re : OUR DEMAND FOR INCREASE IN SUBSIDIZED  
ACCOMMODATION RENTALS &  
PETROL ENTITLEMENT TO SCALE V OFFICERS**

**We are delighted to advise that this festive season has brought reason to rejoice for all of us !** Comrades, we have been keeping all of you updated about our consistent and vigorous efforts to achieve the long pending demand of increase in subsidized rentals. The issue was agreed upon by the Management in the Central Consultative Committee meeting but the implementation was taking too long a period testing our resolve. Friends, we are delighted to advise you all that with our perseverance, strength and protracted follow up, the management has agreed to increase the subsidized rentals as follows:
