Meeting of 4 Officers Organisations in Banking Sector


All Four Officers Organisations in the Banking Sector namely AIBOC, AIBOA, INBOC and NOBO had a meeting at Chennai today. Shri K.K. Nair chaired the meeting.


The following decisions were taken.


1. The focus of the strike, agitations and negotiations should be on Wage Revision upto Scale VII as practiced all along.
2. On Medical Insurance, we should demand 100% reimbursement for self and family without ceiling from the Banks directly. The Insurance Policy if taken by Banks under IBA should have more reimbursement instead of Rs.4 lakhs for officers. It needs to be doubled. The retirees also should be covered by the Banks reimbursement policy.
3. It was decided to write to DFS and 6 Chairmen of Banks on the fractured mandate and also to meet DFS Officials.
4. It was also decided to suggest to UFBU to have the strike on 28th & 29th May 2018 so that there will be better impact.
5. It was also decided to write to the Chairman of Negotiating Committee (Officers) to fix up a meeting to address the unresolved issues listed in the Charter of Demands.
6. On "Grid holidays" a detailed note will be submitted to IBA, as the number of holidays are gradually reduced to the workforce working in service branches.
7. It was also decided to take up with IBA to allow one representative as an observer in the ongoing wage revision exercise.


